**PURPOSE**

This workshop addresses the Boundary section within the Counselor and Social Worker Code of Ethics and reviews paperwork, confidentiality, rules around boundary setting, and dual relationships. Case scenarios will allow participants to discuss issues in ethical practices while working with clients and consumers.

**PURPOSE**

This workshop provides participants with a broad overview of the current opioid epidemic in the country and in Ohio. Participants will learn details about recognizing opioid addiction and its impact on individuals and communities, the present state of addiction and developments in both street drugs and prescriptions, and discuss the future prospects in opioid regulation.

**PRESENTER:**

**Jennifer Haywood, LISW, LICDC,** has been a clinical social worker and addiction specialist since 1996. She has a private practice in Worthington, Ohio, specializing in treating individuals with drug and alcohol addictions, and counseling their families. She also addresses depression, anxiety, post-partum women, women's issues, adolescent issues (14+), and relationship struggles.

She holds a Master's in Social Work from The Ohio State University, and interned in chemical dependency at the Addiction Recovery Center at Harding Hospital in Worthington. She has been helping to train professionals since 1998.
