

Area Agency on Aging, PSA 2 2021 Adult Day Service & General Transportation (for Clark and Miami Counties) Bid Process Letter of Intent Instructions

The Area Agency on Aging, PSA 2 seeks Letters of Intent from service providers who are interested in receiving a contract through a competitive Request For Proposal process for provision of Adult Day Services in Clark and Miami Counties, and General Transportation (for ADS) in Miami County.

The contracts are for the period of February 15 2022 – December 31, 2022.

The availability of funding is contingent upon the annual funding authority received by the Area Agency from the Ohio Department of Aging and any changes imposed at the State level.

Adult Day Service Description

Adult Day Service (ADS) is a regularly-scheduled service delivered at an adult day center in a non-institutional, community-based setting. ADS includes recreational and educational programming to support a consumer's health and independence goals; at least one meal, but no more than two meals per day; and sometimes health status monitoring, skilled therapy services, and transportation to and from the center.

- 2. To download the Letter of Intent (LOI) form posted on the Area Agency website, obtain the form from the provided link. Email the completed LOI as directed.
- 3. The Area Agency must receive the LOI by Monday, November 8, 2021 emailed to Jeanne Mbagwu, jmbagwu@info4seniors.org, Late LOIs will not be accepted.

Proposal Submission Process

- Important: Proposal packets will be sent electronically <u>only</u> to agencies who submit an LOI by requested due date of November 8, 2021.
- 2. Proposal to the Area Agency will include instructions for submission. The completed proposal must be received at the Area Agency office no later than Wednesday, December 8 by 5:00 pm. Late Droposals will not be accepted.

Adult Day Services and General Transportation (For ADS) in Miami County Fiscal Year: February 15, 2022 –December 31, 2022

October 27, 2021	The AAA Advisory Council and Board of Trustees approve the Funding plan in Clark and Miami Counties for Adult Day Services and General Transportation Services.
October 28	The AAA issues a Request for Letters of Intent Legal Notice for Adult Day Services and General Transportation and notice of Virtual Informational Session.
November 1	Informational Session held on Zoom for interested applicants.
November 8	Letters of Intent for Adult Day Services and General Transportation due at the AAA office.
December 8	Adult Day Services and General Transportation proposals due at the AAA office.
Mid-January, 2022	Ad-Hoc Contracting Committee formed if competitive bids are received; AAA staff and Contracting Committee review and make recommendations on competitive proposals; AAA staff reviews non-competitive bids; recommendations are submitted to the AAA Advisory Council.
January 26	The AAA Advisory Council reviews all contract recommendations and makes recommendations to the AAA Board of Trustees.
January 26	The AAA Board of Trustees reviews and approves the contract recommendations.
February 10	The last day for organizations to appeal contracting decisions for Adult Day Services and General Transportation.
