THE #OHIOSTRONGPCATRAINING PROGRAM

This training program is specifically for individuals that are not already qualified to work in home care, in order to address the Personal Care Aide workforce shortage.

PERSONAL CARE AIDE (PCA) WORKFORCE SHORTAGE: A number of the older adults across Ohio needing help in order to live safely and comfortably in their own homes (and avoid the necessity of moving to a senior nursing facility) are currently unable to get the home health services they need because of a shortage of personal care aides. Unfortunately, older adults in our nine-county area in West Central Ohio are not immune to this shortage, and we have seen the effects of this shortage in personal care aides increase over the last few years. Dr. Kathy Stevens, a Del Mar Encore Fellow with The Dayton Foundation, initiated the #OHIOSTRONGPCATRAINING program through the Agency on Aging, PSA2 in 2020 to help address this shortfall by offering free CNA Training. The Area Agency on Aging, PSA2 now continues her work. HELP CONTINUES TO BE NEEDED!!! If you are interested in working in home health care, are compassionate and want to make a big difference in someone's life, please know there are many home care provider agencies currently hiring personal care aides.

Program Costs: There is no cost to apply to this program.

How to apply: Visit a home health provider that is partnered with the Area Agency on Aging, PSA2. You may complete an online application which will be used as an inquiry request, you will then be provided with a list of home health providers you can visit to complete the #OHIOSTRONG application.

Out of pocket expenses for individuals: background check, uniform/scrubs, physical, and TB test. STNA testing is **not** required to work in home health care and is not paid for by this program.

Training Sites: The program is currently partnered with three training sites. The individual can choose the training option that will work best for their life, but must meet the registration requirements. The training company will bill the Area Agency on Aging for the training cost.

NOTE: All are state-approved CNA training courses and include the minimum of 75 hours of IN-PERSON instruction, 59 hours of classroom instruction and 16 hours of hands-on training ("clinical").

ALL PROVIDERS must follow this workflow when submitting an #OHIOSTRONG application:

When an individual comes in to your facility wanting to work as personal care aide but lacks the education/training requirement to be hired:

- 1. Have the individual complete the #OHIOSTRONG application.
- 2. Run the 7 database checks:

 - 8. If someone has lived outside of Ohio in the past 5 years, you must also search the nurse aide registry of the state they previously lived in.

- 3. Please screen these individuals to be sure that it is an individual you would hire once they complete the training. If yes, move to step 4. If no, stop process.
- **4.** Submit the #OHIOSTRONG application, database checks and their photo ID (in one email, please) to Area Agency on Aging, PSA2 at the new email box: pcatrainingprogram@info4seniors.org
 - ***Incomplete applications those submitted without database checks and/or photo ID will not be processed***
- **5.** Application will be processed by Agency on Aging and providers will be notified via email correspondence of approved/denied applications.
- **6.** Approved individuals will be sent a welcome email (the referring provider will be copied). The individual must complete and return a commitment form (selecting the training site and class session they will attend) to the Area Agency on Aging.
- 7. The referring provider will be alerted of the training site and class session the individual chooses.
- **8.** The individual must complete the registration process to enroll at the training site they selected. **Please be aware** there are registration deadlines!
- 9. The individual will attend the classroom and clinical training. Individuals who meet passing criteria will receive a Certified Nurse Aide (CNA) certificate. Each school has minimum passing requirements on classroom (tests/exams) and clinical performance. Class attendance is mandatory. If an individual misses more than 10% of the class time (7.5 hours) they will fail the course. If an individual fails the course they will have to pay to retake the course.
- **10.** Providers will be updated as individuals complete the training. Providers are encouraged to keep list of their #OHIOSTRONG application referrals to follow up with the individuals for recruitment.
- 11. Individuals/Graduates will pick up their CNA certificate from the training site when available.
- 12. Individuals/graduates are encouraged to work for the provider that submitted their #OHIOSTRONG application.
