## **2021 Outstanding Senior Citizen Award**

The Area Agency on Aging, PSA 2 is now accepting nominations for Outstanding Senior Citizen Awards. These awards will be selected by each county and announced in May for Older Americans Month on the Agency's website and summer newsletter. Award information will also be provided to local newspapers in each county. One award will be presented in each county (Champaign, Clark, Darke, Greene, Logan, Miami, Montgomery, Preble, and Shelby).

Individuals and organizations involved with seniors may submit nominations to the Agency for selection by the respective County Council/Coalition on Aging. **Organizations are limited to one nominee per county.** You may copy this form or request additional forms from the Agency office. The form is also available on our website ([www.info4seniors.org](http://www.info4seniors.org)) under "News".

Nomination guidelines for the Outstanding Senior Citizen Award are as follows.

1. Individual must be **60 years of age or older** and a resident of the county for which the award is being presented.
2. Nominee must have been a **legal resident of Ohio** for the past five (5) years or longer.
3. Major emphasis should be placed on **contributions to the community** made by the individual **after reaching age 60**. However, prior contributions may be considered.
4. **Service in any field of endeavor** should be considered (e.g., education, radio, television, business, medicine, art, music, journalism, religion, athletics, politics, volunteer service).
5. A **husband and wife** may receive the award jointly when both have been involved in service and various community endeavors.
6. **No individual or couple will be eligible who has previously received this award.**

**All nominations must be received at the Area Agency on Aging, PSA 2 by March 26, 2021.**
